The meeting was closed at 7:30p.m for member of the public to address the Committee

Concerns were highlighted including:

The lack of reference to the Grave located within the boundary of the proposed development of Robert W Russell

The Dangerous entrance to the Carpark close by to the Pedestrian Crossing at Market Place, South Cave

The detrimental Impact on the Conservation Area, Street Scene and the Grade 11 Listed Buildings at Market Place, South Cave

The impact of the loss of a community asset (ACV) and the need of preservation of community life

The comparison of Pub numbers in neighbouring villages, and the questioning of the owners overall intentions of both pubs within South Cave

The resident strongly request the Parish Council recommend refusal of the application

The meeting was re-opened at 7:35p.m

Cllr M. Turner proposed the Parish Council recommend refusal of the application which would have a detrimental impact upon South Cave Conservation Area. Market Place includes Grade II listed assets, with open areas not disturbed by developments. The proposed modern development would not compliment the conservation area and would cause substantial harm to the characteristic of Market Place and Church Street.

The proposed development would have a detrimental impact on the Boundary of the plot, the tree screen which was originally planted as a boundary between Wesley Close and Market Place, South Cave. The loss of this screen would have a significant detrimental impact on the character and appearance of the conservation area and the Parish Council request the East Riding of Yorkshire Council place Tree Preservation Orders on tree screen as a matter of urgency, due to these trees currently being under threat.

The vehicular access is unsuitable for additional traffic movements and would increase potential hazards to pedestrians using the Zebra Crossing. The provision of turning facilities are not included within the proposals, forcing Emergency Vehicles and Facility Vehicles to turn within the Highway at Market Place at the Zebra Crossing causing hazards to both pedestrian users and other vehicles.

South Cave is subject to a number of approved sites for development amounting to 221 additional dwellings, this application would increase these numbers further exceeding the required supply. The development would significantly impact on Parking at Market Place which is currently exceeding its capacity for the provision of parking for residents and local businesses. Additional provision of Parking at Market Place should be considered prior to any future development of premises at Market Place being approved.

The loss of this recently designated ACV would have a detrimental effect community life.
