Cllr Barnett proposed the Parish Council recommend refusal of the application due to the tree having a significant impact on the streetscene to the entrance of the village. The loss of the tree would have

a detrimental impact and the application provided no evidence of the tree being Dead, Dying or dangerous. Seconded Cllr Munby, All in favour.

Cllr M. Turner proposed the Parish Council raise no objection to work to be completed on trees T1 & T2, the Parish Council were unable to submit comment relating to trees T10, T11, Conifer and the Conifer |Hedge sure to insufficient information being provided and also the report differing with information relating to the intentions to the Hedge to the description received from ERYC. The Parish Council request clarification be submitted prior to a decision being made by the ERYC in order for the Parish Council to consider the remainder of the application. Cllr Kingdom proposed the Parish Council recommend refusal of the application due to the trees forming part of the original tree screen planted in order to screen the Castle from the new development of Castle Rise. The tree screen is slowly being compromised and the loss or excessive pruning of any trees within the tree screen will have a detrimental impact on the streetscene. If the ERYC are minded to approve the application, the Parish Council would request the ERYC impose a 2 metre as maximum lift under the supervision of the Tree Officer. Seconded Cllr L. Turner, All in favour.
