Cllr Barnett proposed the Parish Council recommend refusal to the application due to:

Overmassing/overdevelopment of the site

The repositioning of the waste bin area should not be adjoining neighbours properties and the council have concerns with the "yellow bin" waste leading to health and safety & vermin problems.

The loss of 3 to 4 car parking spaces leading to on street car parking problems in the adjacent residential area .

Concerns were raised for the access for emergency services

Delivery of supplies currently cause early morning noise problems therefore building the cinema moves the access path to the rear kitchen closer to the Wold View properties causing additional loss of privacy and noise problems.
