First Fruits: We are delighted to announce we have negotiated a new 25 year lease with the East Riding of Yorkshire Council.



We have almost 2 acres of land in South Cave, where we meet up to grow fruit & vegetables and share the harvest.


Everyone is welcome, whatever your fitness level. Coming along to First Fruits would be an ideal opportunity for anyone on the garden allotment waiting list to experience and learn how to "Grow Your Own".

No previous experience needed. Come and learn something new or bring your own growing skills along to teach us.

In order to cover the basic costs, the current fee is £30 a year. We are also members of The National Allotment Society. Occasionally we may ask for voluntary donations to cover projects as they arise.

We meet all year round. Sometimes we are wearing thermals and sometimes sun cream. There's always something to do!

We enjoy fresh air, exercise and meeting up with friends old and new. We share a huge variety of vegetables, soft fruit, orchard fruit and nuts. DOG FOULING.

Once again, the Parish Council has received several more complaints regarding dog fouling. Most dog owners/walkers in South Cave behave responsibly and give regard and respect to all of us, but unfortunately there are a few who make our pavements unpleasant places to walk and spoil our lovely village. We are fortunate in having a generous number of bins and whilst the dogs are not at fault, **IT IS AN OFFENCE** to allow your dog to foul in a public area.

THE SOPHIE AND ELIZABETH BARNARD TRUST

This trust is one of the unique and ancient traditions of South Cave. We are endeavouring to keep it "alive" despite compulsory £60.00 bank charges.

The trust was set up after the will of Elizabeth Barnard, which was written in 1871, to honour her husbands' anniversary. Mrs Barnard left £1000, less taxes, to be distributed amongst the widows, or poor of the parish annually. Obviously this money has dwindled considerably over the years. The trustees meet annually and distribute accordingly. The amount, by today's standards is considerably smaller but so far we have managed to keep this tradition alive, and we are endeavouring to continue this village tradition.

MIRES BECK

Our service users, now numbering around 100, have been very busy throughout the winter months preparing to re-open to the public for plant sales 7 days a week from March 1st. We're introducing more than 70 new species this season, taking the choice of herbaceous perennials to well over 500, along with 50 popular herbs and 100 Yorkshire provenance wildflowers. As well as garden centres across Yorkshire and Lincolnshire, we're proud to say that our wholesale customers now include Chatsworth House, Harewood House, 4 English Heritage and 10 National Trust properties.



Grants for Local Charities

If you run a community group or charity in South Cave, you may be eligible for a small grant from the Parish Council. This is to help with your activities or to contribute to a special project.

Riparian Ownership responsibilities with watercourses

If you or your business owns land or property through which a river, stream or watercourse passes you are a riparian owner. Furthermore, where a watercourse forms a boundary with your property it is likely that you, as the adjacent landowner, have riparian responsibilities up to the centre line of the watercourse (unless compelling evidence such as property deeds suggests otherwise).

Riparian owners have an important part to play in the East Riding and we encourage our residents, businesses, and landowners to consider the guidance available and ensure they are aware of their responsibilities as riparian owners if applicable.

Updated national guidance for the responsibilities as a riparian owner has been published on the government website by the Environment Agency. The guidance includes information on permits or consents you may need if carrying out works on or near a watercourse. By following the guidance, you can not only help to reduce the risk of flooding but also play a part in preventing pollution and protecting wildlife.

If you are unsure if you are a riparian owner, check the deeds to the property or contact your landlord.

The National Parks & Wildlife Service (NPWS) of the Department of Housing, Local Government and Heritage is reminding the public that the cutting, grubbing, burning or other destruction of “vegetation growing in any hedge or ditch” between the 1st March and 31st August is prohibited to protect birds nests.
