## OSC 633- Playpark

(1)The Committee received update relating to Playpark maintenance & tree report, it was noted some maintenance work to the playpark had been completed to timers in various locations.

The tree report had been completed by First Trees Ltd, it was noted two trees were identified as requiring further investigations from December 2025 and prior to spring 2026. Clerk to arrange prices for these inspections.

It was noted the report included the tree to the entrance of the playpark, ownership of the ERYC. Clerk to forward report over to ERYC to action.

(2)The committee received notes from Sports & Rec AGM – with no comment to make/ tree report tree report being completed

## OSC 634 – Cemetery

(1)The Committee discussed the problem with Cemetery vermin controls, it was noted further controls to imit vermin were required with investigations ongoing

(2)The Committee considered additional memorial seat for Garden of Remembrance as offer of donation. It was concluded the current provision of seats to be sufficient with no space at present for any additional installations. A waiting list to be arranged for donations for replacement seat when necessary. Proposed Cllr Edmond, Seconded Cllr Turner, All in favour.

## OSC 635 - Allotments

(1)The Committee discussed the Allotments & considered requests –

5E Water bowser – not permitted out of character and would not be permitted

13E – The tree in the pot is acceptable, the fig tree & olive trees are not suitable for the allotment due to its potential size planted in the ground.

Berry Bushes – acceptable within the allotment plot but kept at a reasonable height and not planted around the boundary

- (2)The Committee received update relating to Humber Forest application approved planting to commence September 2025
- (3)The allotment agreements for 2026/27 were reviewed with no amendments made at this time it was noted any alterations be made before April 2026

### OSC 636 - Queen Elizabeth II / Bull Pasture

(1)The Committee improvements for outdoor space - It was note Bull Pasture is ERYC land, Youth provision was discussed, it was suggested a Young Person survey be included with in the next parish newsletter gathering thoughts and ideas on what would best suit the area and young people within the village.
