Ash tree (T1) (in height) and to reduce both shading and dominance over the garden; Crown reduce 1 no. Birch tree (T3) and 1 no. Maple tree (T4) (in height) to reduce both shading and dominance over the garden; Crown reduce 1 no. The Parish Council would request confirmation the Tree Officer has seen evidence of a report for the application. It should

be noted the Parish Council request ERYC submit full evidence of this for future applications and request the ERYC ensure the following points are considered:

- All tree surgery should be in accordance with BS3998 (2010) to ensure that all works are carried
 out in an arboriculturally acceptable manner.
- Climbing spikes should not be used whilst undertaking any form of works on living trees to ensure undue, extensive, and long-term damage is not inflicted upon protected trees.
- To maintain the character and appearance of the Conservation Area the Parish Council request ERYC to encourage and recommend where possible the planting of a suitable replacement tree(s) following the removal of existing trees.
- If applicable, a BS5837 Tree Survey and Report is an essential process for anyone planning construction or development where trees are present either within or adjacent to your property. Seconded Cllr Stephenson vote 7 in favour, 1 against 1 abstention (4) 25/01947/PLF

Proposal: Erection of single storey extension with raised patio area to rear, alterations to existing porch to front and installation of rooflights to front and rear Location: 11 Castle Rise South Cave East Riding Of Yorkshire HU15 2ET Applicant: Application Type: Mr and Mrs Nicholls Full Planning Permission

Cllr Turner proposed the Parish Council raise no objection to the application however raised concerns with the following:

The application documents state that trees and hedges will be affected by the alterations as can be seen from the proposed floor plans; therefore, an Arboriculture Report should have been submitted as the proposed drawings do not identify what is to happen with 2 no. conifers and a tree identified as T1.

Concerns were raised with the raised stepped area to the patio, the Parsh Council request the ERYC review the proposed plans to ensure all proposals are within safety regulations Seconded Cllr Stubbs, All in favour
