Proposal: Erection of single storey extension to rear following partial demolition of existing extension, installation of rooflights in roof at rear, conversion of existing outbuildings to form additional accommodation with replacement roof and installation of roof light, replacement of existing coal hatch opening with window at side and other external alterations Location: 29 Church Street South Cave East Riding Of Yorkshire HU15 2EH Applicant: Application Type: Mr & Mrs Phil Scott Full Planning Permission. Cllr Edmond proposed the Parish Council raises no objection in principle to the application; however, concerns have been expressed regarding the impact on parking facilities on Church Street during the course of the works. The Parish Council requests that East Riding of Yorkshire Council (ERYC) and Highways ensure that appropriate conditions are imposed to minimize parking disruption during the works. These conditions should include:

- (1)Designated locations for skip placement.
- (2)Clear delivery times for materials.

By implementing these conditions, ERYC will be in a position to enforce actions should the parking situation deteriorate and affect neighbouring properties or parking arrangements. Seconded Cllr Turner, 6 in favour, 1 abstention.

Specifically, the Parish Council proposes that funding be allocated to reduce the speed limit on Common Road to 40mph.

This request is made due to:

The absence of a footpath on Common Road, which currently does not provide adequate protection for pedestrians.

The anticipated increase in vehicle movements on Common Road as a result of the development. The reduction in speed limit would improve safety for both pedestrians and vehicles in the area. Seconded Clir Turner, All in favour
