The Meeting of South Cave Parish Council took place in the Town Hall, Market Place, South Cave commencing at 7:00pm.

Public Forum

Residents have expressed increasing concern and frustration regarding the lack of management for parking in the Market Place area. It was highlighted that any parking-related issues, should be reported through the appropriate channels.

It was noted that *Operation Snap* could be used to report driving offenses, though not parking violations. *Operation Snap* is a UK-wide initiative that allows the public to submit video or photographic evidence (from dashcams, phones, etc.) of driving offenses such as:

- Handheld mobile phone use
- Dangerous or careless driving
- Ignoring red lights or solid white lines
- Not wearing a seatbelt
- Dangerous overtaking

The initiative is focused solely on driving offenses, and not on parking violations or road traffic collisions. If an offense is identified through submitted evidence, the driver may face prosecution, fines, points on their license, or a driver improvement course.

For parking issues specifically, residents should refer to the local council or parking enforcement for further guidance.

Open Space

(1)The Parish Council noted Playpark Trees had been assessed by the Sports and Recreation and had requested a meeting to compare and discuss reports with Chair and a representative from the Sports and Recreation

(2) The Parish Council received a response from Anchor Housing regarding the hedge work at King George V Playing Field. It was noted that, with the exception of one resident, all residents at Wold View had agreed to maintain their own hedge. The original complainant had been informed that they were responsible for maintaining their side of the hedge.

As a one-off arrangement, the Parish Council agreed to trim the roadside hedge between properties 35 and 36, but there was no authorization given for the contractor to enter either property to trim within their boundaries.
